CHHATTISGARH NON-GOVERNMENT SCHOOLS FEES REGULATION ACT, 2020.

An Act to give legal basis to mutual consultation among school management and guardians in the process of fixation of fees in Non-Government Schools and to provide the procedure for fixation of fees.

Be it enacted by the Chhattisgarh Legislature in the Seventy-First Year of the Republic of India, as follows:-

CHAPTER-I PRELIMINARY

 (1) This Act may be called Chhattisgarh Non-Government Schools Fees Regulation Act, 2020.

Short title, extent and commencement.

- (2) It shall extend to the whole State of Chhattisgarh.
- (3) It shall come into force from the date of its publication in the Official Gazette.
